For school budget planning, the fringe benefit rates (fiscal year 2009-2010) listed below are to be used.

Effective with the 1991-92 school year the District must pay Social Security for all employees who are not covere by a retirement system. This means that all certificated and classified assignments of less than half-time as well as all unclassified assignments (with the exception of Student Aides) will now be subject to Social Securit contributions as well as Workers' Compensation, Unemployment Insurance and Medicaré. Teacher Assistants and Counseling Assistants are also subject to these contributions since they are not participating in a retirement system
